Mimosa Morning...

Come join us on Saturday, July 30th at the patio area. Roosevelt Lake Marina will start your morning off right with mimosa's.

Safety Precautions...

Batteries needing to be disposed of should be left by the trash receptacles at the end of each row of slips. Any batteries left at an individual slip will be taken away and disposed of. Portable tanks with gas in them should not be brought on property, stored at the slip or on boats as this is a fire hazard.

Launch/Retrieval Service...

Launch and retrieval service can be scheduled between the hours of 8am - 4pm. We can only accommodate this service outside these times if enough advance notice is given to re-schedule our launching staff.

If you are wanting to launch/retrieve your own boat at Windy Hill, access into the dry storage area can be granted during the day and/or evening.

Monsoon season...

With the upcoming monsoon season, it is very important that you only tie your dock lines to the dock cleats and not to any poles. If boats are not properly secured, RLM staff will secure them with adequate lines at the owners expense.

Restroom Facilities...

The restroom renovations should be completed next week. These new facilities will be located adjacent to the members' bathrooms. Please use these facilities when you do not need to utilize the showers. Additionally, it would help greatly if everyone would limit their use of the shower facilities to 10—15 minutes. We are planning to increase the number of showers for customers' use in the near future.

Portable Carts...

We are planning to provide portable carts for members' use in transporting items to their boat in the very near future. Shuttles will still be offered to customers as a courtesy service.

Member Charge Accounts...

As of August 1, we anticipate changing our accounting system in the store; therefore, we will not be able to have members charge to their accounts until/if we are able to offer this service on the new software. Purchases can be made by cash, credit card or check (with license identification).

Pets...

With the increase in traffic at the marina we have seen an increase in our dog population. We love dogs, however not when they run free on the docks and relieve themselves in the public areas. This is very discourteous to your slip neighbors! It is essential that all dogs are on a leash while at the marina and mandatory that they relieve themselves in the dog relief platform located on the right side of the walkway when approaching the marina. We ask every pet owner to cooperate with us in order to avoid banning pets on the property. Please understand that if your dog is seen unleashed, you will be asked to discontinue bringing your pet on RLM's property any longer.

Additionally, it is a health violation to have pets in the bar/grill area, so PLEASE no drinking and dogging!!!
